- **Solid Waste Disposal Agreement:** Council reviewed the amended Solid Waste Disposal Agreement between the City of Troy and the City of Moscow regarding the tipping fee increase from 1.5% annually to 2.5%. After a brief discussion, councilwoman Cindy Gray made a motion to approve the amended agreement. It was seconded by Councilman Patrick Cordova. Motion passed by a roll call vote all in favor (*Gray, Abbott Cordova*). **Motion carried.**
- **Strom Electric:** Council reviewed the bid estimate from Strom Electric to install outside outlets at City Hall. After a brief discussion, the topic was tabled till the next meeting with the request to source other bids for price comparison.
