- **FY2026 Budget Ordinance #2025-02**: Council consideration and action on Budget Ordinance #2025-02.
- **Investment Pool / Sewer Debt Service Fund**: Authorization to transfer \$73,500 to the Sewer Debt Service Fund (State Investment Pool Acct. #4216), as discussed on 08/13/25.
