FY2026 BUDGET: City accountant Greg Mann will present and discuss the proposed FY26 Budget. Input from council requested.

AMBULANCE PURCHASE: Council to review and take action on agreement between the City of Troy and the Troy Volunteer EMT.

702 Tree Removal: Per the agreement between the City and ITD, the Idaho Transportation Department is not responsible for trees located within City limits along improved roadsides. City Hall AC/Furnace Replacement: Council to review and take action on quotes received for replacing the AC/Furnace at City Hall.

BMS UB Agreement: Council to review and take action on estimate and agreement with Black Mountain Software for Merchant services and Cloud Hosting.

Computer Upgrades: Council to review and approve estimates for computer upgrades at City Hall and the City Shop to Windows 11. This upgrade is necessary as Windows 10 will no longer receive security updates, and some programs will become incompatible after October 2025, when the change takes effect.
